SUBJ: Accounting for September 10, 2009 amounts from the Education Fund

On September 10, 2009 the first of three payments from the FY 2010 Education Fund was disbursed. The figures below are the final amounts for categorical grants owed the School district by the Education Fund. Details of how the netted amount was calculated may be found in the Preliminary FY 2010 "Cash Flow" sheets distributed by the Department of Education in mid-September.

To ensure consistent data throughout the State when reporting financial information, we ask that you record this payment using the Revenue Codes and the amounts shown below.

Due to rounding conventions, the net amounts shown may differ by one dollar from the amount shown for the September 10, 2010 payments on the Preliminary FY 2010 "Cash Flow" sheets (page 2). The sum totals of the three amounts will equal the correct amount for the districts.

Note: The negative adjustment in 3110 is due to a situation where property taxes collected are greater than the total amount owed to a school district from its education spending but not great enough to fully cover categorical grants owed the district. In order to record the full amount of the categorical grant, revenue code 3110 from the town must be reduced.
