H. Out of District Placements

OUT OF DISTRICT PLACEMENTS

There are three types of out-of-district placements.

- When a Local Education Agency (LEA) pays tuition to send a student to a program operated by another public school.
- When a LEA pays tuition to send a student to a private school that has been approved by the Department of Education to offer special education services.
- When a student attends an out-of-district public school either because the district does not operate a school for their grade or due to school choice.

Only the district of residence has the right to bill Medicaid.

PUBLIC SCHOOL PROGRAMS

Public schools can develop specialized programs and operate the program as part of the school. In many cases these programs specialize in a certain disability area and accept students tuitioned from other districts.

INDEPENDENT SCHOOLS

An approved independent school is an educational entity which has made application to the DOE, gone through a specific sequenced process and has obtained approval from the State Board of Education. The process is outlined in 16 V.S.A §166. Approved Independent Schools do not need to address the Public School Standards or operate within the Frameworks of Learning Opportunities; both of which are required of all public schools.

NO DISTRICT OPERATED SCHOOL/SCHOOL CHOICE

When a district does not operate a school for a certain grade(s), students are tuitioned to another public school. Some students attend a public school outside their district of residence due to school choice.

OUT-OF-DISTRICT PROVIDER CERTIFICATION AGREEMENT

When a student is attending an out-of-district program, the sending school needs to obtain a signed copy of the Out-of-District Provider Certification Agreement before level of care claims can be submitted to Medicaid. This form does not indicate the individual credentials of the providers working with the student. If there is a question about an individual's credentials the sending school should contact the out-of-district school. It is acceptable for the sending district to obtain copies of the Provider Certification Agreement and licensing information in lieu of this form.

The Out-of-District Provider Certification Agreement must be signed once a year.

AGREEMENTS FOR DOCUMENTATION BETWEEN PUBLIC SCHOOLS FOR TUITIONED STUDENTS

When Medicaid eligible students attend a school outside of the district where they reside, the school districts need to work out an agreement to ensure that the appropriate documentation exists for Medicaid billing if the student is receiving billable services. The sending school district (district where student resides) will need to have all the provider documentation before it can submit bills. The Medicaid field representatives may be able to facilitate the sharing of information among the supervisory unions.

Independent schools that are not enrolled Medicaid providers, such as St. Johnsbury Academy, Burr & Burton Academy, Lyndon Institute and Thetford Academy should be treated as out of district schools.

OTHER

If a student is attending a school that is not approved for special education services, a LOC is not billable. The sending school can bill for the IEP (blue form) and the reevaluation (pink form) as long as a Release of Information form is on file.

A list of the Vermont Independent Schools approved for providing special education is included in this section. If you have problems working with an independent school, you can contact the Medicaid Program Coordinator at 828-5111.

SCHOOL CALENDARS/PROFESSIONAL PROVIDERS

Medicaid field representatives collect and maintain calendars for independent schools and a list of the professional providers.
