Vermont Testing Requirements for Educator Licensure

Academic Skills for Vermont Educators

Candidates seeking initial educator licensure in Vermont who do not hold a current non-conditional out-of-state-license from a state that has signed the NASDTEC agreement are required to meet the passing scores established by the Vermont Standards Board for Professional Educators (VSBPE) for the **Praxis Core Academic Skills for Educators (CORE®)**. Educational Testing Services (ETS) has completely phased out Praxis I, which means the tests are no longer available. The **Praxis Core tests** have replaced the Praxis I. The core academic skills tests for educators include three tests: Reading (5712), Writing (5722), and Mathematics (5732). The Praxis Core subtests measure whether educators have the necessary reading, writing, and mathematical knowledge/skills. The Praxis Core does not assess one's knowledge of teaching nor does it predict who will become a good teacher or administrator. All candidates need to pass *each and every one* of the Core tests to be eligible for licensure; there is no combined score for Praxis Core tests.

Praxis Core Academic Skills Test

Combined Test (includes Reading, Writing, and Mathematics Tests): Test Code 5751 (Cost - \$150.00)

Reading: Test Code 5712 – pass score is 156 (Cost \$50.00 registration fee plus \$40.00 per test)

Writing: Test Code 5722 – pass score is 162 (Cost \$50.00 registration fee plus \$40.00 per test)

Mathematics: Test Code 5732– pass score is 150 (Cost \$50.00 registration fee plus \$40.00 per test)

Alternatives to Praxis Core Series: Qualifying Praxis I or qualifying SAT, ACT, or GRE scores can be accepted if the test scores meet the following pass scores:

1. **Qualifying Praxis I pass scores:**
Reading – pass score 177
Writing – pass score 174
Mathematics – pass score 175
Combined score - 526
2. **Qualifying SAT scores:** Combined score of 1000 and minimum Verbal (420) and Math (470) scores if taken before April 1, 1995 or combined score of 1100 and minimum Verbal (500) and Math (500) if taken after April 1, 1995. For SAT scores contact [College Board](#) . Please reference **Vermont recipient code #4142** (Your “reading” SAT score is equivalent to the “verbal” score. The writing SAT score will not be counted.)
3. **Qualifying ACT scores:** English 22, Math 22. For ACT scores contact [ACT Records](#) and request test scores be sent to VT **using recipient code #4331**.
4. **Qualifying GRE scores:** Combined score of 1100 and a minimum Verbal (500) and Quantitative (500) if taken before August 1, 2011 or combined score of 300 and a

minimum Verbal (153) and Quantitative (144) if taken after August 1, 2011. For GRE scores contact [ETS](#) . Please note ETS will not send scores directly to the AOE. You may upload test score reports into your online application(s).

Praxis II Content Tests: *Praxis II content tests are required for the following content areas for all candidates unless you hold a valid non-conditional license in the same endorsement area from a State that has signed the NASDTEC agreement.*

- **Art:** Test Code 5135 – pass score is 161 (Cost \$50.00 registration fee plus \$146.00 test fee)
- **Early Childhood Education:** Test Code 5001 if seeking K-3 level of endorsement. (See Elementary Education for test details, effective until July 2018) OR for educators receiving the endorsement at the PreK- Grade 3 or Birth- Grade 3 span: Early Childhood Education Praxis II Test 5025 – pass score is 156
- **Elementary Education:** Test Code 5001 – see individual test scores below. (Cost \$170.00)
- **Reading:** Test Code 5002 – pass score is 157 (Cost \$50.00 registration fee plus \$60.00 per test)
- **Math:** Test Code 5003 - pass score is 157 (Cost \$50.00 registration fee plus \$60.00 per test)
- **Social Studies:** Test Code 5004 - pass score is 155 (Cost \$50.00 registration fee plus \$60.00 per test)
- **Science:** Test Code 5005 - pass score is 159 (Cost \$50.00 registration fee plus \$60.00 per test)
- **English:** Test Code 5039 – pass score is 168 (Cost \$50.00 registration fee plus \$146.00 test fee)
- **English to Speakers of other Languages:** Test Code 5362/0362 – pass score is 155 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **Health:** Test Code 5551 – pass score is 163 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **Math:** Test Code 5161 – pass score is 160 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **Middle Grades English:** Test Code 5047 – pass score is 164 (Cost \$50.00 registration fee plus \$146.00 test fee). Note: the English test can be used to satisfy the Middle Grades English testing requirements.
- **Middle Grades Math:** Test Code 5169 – pass score is 165 (Cost \$50.00 registration fee plus \$120.00 test fee). Note: the Math test can be used to satisfy the Middle Grades Math testing requirements.
- **Middle Grades Science:** Test Code 5440 – pass score is 150 (Cost \$50.00 registration fee plus \$120.00 test fee). Note: the General Science test can be used to satisfy the Middle Grades Science testing requirements.
- **Middle Grades Social Studies:** Test Code 5089 – pass score is 165 (Cost \$50.00 registration fee plus \$146.00 test fee). Note: the English test can be used to satisfy the Middle Grades English testing requirements.
- **Music:** Test Code 5114 – pass score is 162 (Cost \$50.00 registration fee plus \$146.00 test fee)
- **Modern and Classical Language: American Sign Language.** Test Code 0634 – pass score is 3+ or 170 (Cost \$50.00 registration fee plus \$146.00 test fee)
- **Modern and Classical Language: Latin.** Test Code 5601 – pass score is 147 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **Modern and Classical Language: French.** Test Code 5174 – pass score is 162 (Cost \$50.00 registration fee plus \$160.00 test fee)
- **Modern and Classical Language: German.** Test Code 5183 – pass score is 163 (Cost \$50.00 registration fee plus \$160.00 test fee)

- **Modern and Classical Language: Spanish.** Test Code 5195 – pass score is 168 (Cost \$50.00 registration fee plus \$160.00 test fee)
- **Modern and Classical Language: Chinese.** Test Code 5665 – pass score is 164 (Cost \$50.00 registration fee plus \$160.00 test fee)
- **Physical Education:** Test Code 5095 – pass score is 169 (Cost \$50.00 registration fee plus \$146.00 test fee)
- **Reading ELA Specialist:** Test Code 5301 – pass score is 164 (Cost \$50.00 registration fee plus \$146.00 test fee)
- **Science:** For a full science endorsement, candidates must meet a passing score on the General Science AND one subject specific test of their choosing. A limited endorsement in a science content area requires passing the Biology, Chemistry, Earth Science or Physics test.
- **General Science:** Test Code 5435 – pass score is 157 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **Biology:** Test Code 5235 – pass score is 151 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **Chemistry:** Test Code 5245 – pass score is 160 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **Earth Science:** Test Code 5571 – pass score is 158 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **Physics:** Test Code 5465 – pass score is 140 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **Social Studies:** Test Code 5086 – pass score is 153 (Cost \$50.00 registration fee plus \$146.00 test fee)
- **School Psychologist:** Test Code 5402 – pass score is 147 (Cost \$50.00 registration fee plus \$120.00 test fee)
- **School Leaders Licensure Assessment:** Test Code 6011 – pass score is 163 (Cost \$50.00 registration fee plus \$425.00 test fee)

FREQUENTLY ASKED QUESTIONS

Who is exempt from taking Core Academic tests and Praxis II tests?

- Candidates who hold a current professional educator license in a state that has signed the NASDTEC agreement and are applying for an initial VT license in the endorsement area being sought
- Candidates who otherwise qualify for licensure/endorsement and have achieved National Board Certification®
- Educators seeking endorsement as
 - Driver and Traffic Safety Education (in-vehicle instruction only)
 - Junior ROTC Instructor
 - School Nurse
 - Associate School Nurse
 - School Psychologist
 - Social Worker
 - Work-based Learning Coordinator

Do I have to pay a registration fee each time I register to take a Praxis test? No. Test takers are required to pay the registration fee only once during a testing year.

I have taken my test; how long before the AOE gets my results? Scores will be available to candidate immediately after taking most tests. ETS sends scores to the AOE approximately two weeks after the test date.

I took the Praxis II Elementary Education test and failed one section; what do I do now? A candidate who fails a section must re-take that section only.

I took the Praxis I or the Praxis Core tests for Educators and failed a section; what do I do now? Praxis I tests are no longer available. A candidate that failed a section of Praxis I (e.g., math) must now take the corresponding Core Academic Series exam (e.g., math). A candidate that fails any section(s) of the Core Academic Series must re-take the section(s).

I took the Praxis I & II tests a few years ago in a different state. Can I use those scores or do I have to take the test again? If candidates complete tests that have the same test codes as the tests Vermont has adopted and the scores meet or exceed Vermont's passing scores, these scores can be used. Candidates should contact the Educational Testing Service and request that an official score report be sent to the Vermont Agency of Education using recipient code "8410."

How do Vermont's testing requirements apply to Peer Review candidates? Peer Review candidates must meet all licensure testing requirements that are in effect when the Licensing Office receives the candidate's application for a license. Please note that Peer Review candidates can only apply for a license after the panel has recommended the candidate for licensure and the candidate has received written confirmation of such from the Licensing Office.

I am applying for Educational SLP licensure in Vermont. What tests are required? Applicants for the Educational Speech Language Pathology endorsement must meet the passing scores for the Core Academic Series or an alternative to this series described in this brochure.

I previously held a Vermont educator license and wish to reinstate it. Do I have to meet the testing requirements?

No. Vermont's testing requirements do not need to be met for reinstatement of a previously held educator license.

I am applying for the science endorsement limited to a specific science subject (i.e., biology, chemistry, physics, or earth science). Do I need to take a Praxis II General Science Subject Assessment test? No. Applicants are required to meet Vermont's passing score on the applicable Praxis II subject specific test only.

If I passed a Praxis II content knowledge test (English, math, science or social studies), do I also need to pass a middle grades Praxis test in the same content area to obtain a middle grades endorsement? No. A Praxis II passing score in a secondary content area will meet the testing requirements for the middle grades endorsement in that same content area. For the middle grades science endorsement, the general science test can be substituted for the middle grades science test. NOTE: Middle Grades Praxis II content tests cannot be used for secondary English, math, Social Studies or Science endorsements.

Can I have my college send the AOE my test scores? No, only test scores received **directly from ETS** will be considered official.

I am seeking an endorsement in a Modern and Classical Language not tested by Praxis II. What test do I need to take (e.g. Italian)? In all languages without an assigned Praxis II exam, ACTFL or ASLTA testing is required to demonstrate proficiency. For more info click [here](#).

Can scores be used from other state required tests such as the MTEL, NYSTE, CBEST, NTE, etc.? No. Only passing SAT, ACT, GRE or Praxis I scores can be used, in lieu of, the Praxis CORE. There is no replacement for the required Praxis II test in the subject matter for which you have been recommended for licensure.

ETS INFORMATION

How do I register? Go to [ETS](#) for registration information. You can register online or via US mail.

Are special accommodations available if required by the test taker? The following accommodations are available: extended time for test takers whose primary language is not English, Monday testing for test takers whose military service or religious convictions prevent testing on Saturday, and non-standard testing accommodations for test takers with documented health-related needs or disabilities. **Consult the Praxis website [here](#)**, for additional information regarding what's required to qualify.

What if I need to cancel or reschedule my test prior to my test date? You may cancel or reschedule your test online or by calling ETS Customer Service at 1-800-772-9476 no later than four full days prior to your test date (not including the day of your test). If you cancel within this time frame, you may be eligible for a 50% refund of your test fees. [Contact ETS](#) for more information about cancellation, rescheduling and refunds.

When will I receive my scores?

Computer-Delivered Tests: As stated previously, scores for tests that are administered continuously will be available 2-3 weeks after the testing window closes (regardless of the specific day on which you tested within that window). Official score reports will be available online for 1 calendar year from the score reporting date. You can view your unofficial multiple-choice scores for certain tests at the test center. Because of the scoring process for constructed-response questions, your scores for tests containing constructed-response questions will not be available at the test center.

IMPORTANT INFORMATION

- **VERMONT COMPUTER BASED TESTING LOCATION:** Prometric Services, 600 Blair Park Rd, Williston VT 05495. To register you must go to the [ETS website](#).
- It is the agency's expectation that an applicant who is required to meet the testing requirement, request their passing test scores to be sent to our agency. There is a cost for this service. Therefore, the agency strongly advises that applicants ensure that their testing scores meet the pass score **before placing an order**.

- Test scores submitted by an applicant or an applicant's college **CANNOT** be accepted **UNLESS** the passing scores being submitted were for a PRAXIS I or SAT or ACT test taken **more than** 10 years ago. For tests taken more than 10 years ago, the agency will accept a NOTARIZED paper copy of passing scores. The Notary will attest to the fact that the test scores are a true/accurate copy.
- If you test in Vermont, your score report will be sent automatically to the Vermont Agency of Education. If you test outside of Vermont, select the Vermont Agency of Education (**State Code 8410**) as a score recipient when you register or on an additional score report request.
- ETS has discontinued paper-delivered testing. However, tests will be available in a paper-delivered format as required for ADA accommodations. All scores for previously administered paper-delivered tests are reportable for 10 years from the date the test was taken. Note: the Assessment of Signed Communication – American Sign Language test (0632) will continue to be delivered in its current format.
