Discussion around updating bylaws:

The Executive Committee seeks to make changes to SEAP bylaws in order to enable Panel to meet federal mandated function while reducing certain identified barriers. Committee anticipates proposing changes to full panel in areas of Quorum, Designee, and Voting. Katie to consult with AOE Legal regarding voting opportunities (i.e. members vote by email on certain warned items, designee voting by proxy).

Full Panel will get update from AOE Legal on Open Meeting Laws at next meeting. ExCom sees updating bylaws as an interactive process while committee grows and develops into its intended functions.

Will present draft to Full Panel for December 14th Meeting. Executive Committee anticipate final draft for 12/21 meeting. Warn for voting at February 2024 full panel meeting.

Updates from membership discussion

Barriers to appointment of members, collaboration with Governor's office to identify barriers. Some members' applications were approved within weeks while others, for legally required members, have been pending for expended period of time. The Governor's office does not have a record of applications, Katie will have applications reforwarded directly to Gov. Scott's appointee manager. One identified barrier and strength is that Gov. Scott personally vets each proposed appointee.

Some discussion of panel recent historical context – Discussed need to grow membership. Once current members are approved, anticipate engaging in recruitment effort. JK, TC, and MC will collaborate to develop recruitment strategy. Hope to roll out Jan/Feb.

Identify need for greater diversity on panel, discussed reviewing GMSA Diversity, Equity, Inclusion, and Belonging self-assessment tool.
