

Every child can read by third grade and striving adolescent readers are supported, ensuring all students are ready for college or career.



About Read Vermont

Comprehensive statewide initiative dedicated to improving literacy outcomes for Vermont students.

- Literacy is a shared priority supported by educators, caregivers and families, the General Assembly, and the Literacy Advisory Council on Literacy
- Common needs and opportunities identified to inform Read Vermont as a comprehensive statewide initiative
- Designed to improve both local capacity and state capacity

Shared Vision for Literacy

Delivering high-quality reading and writing instruction based on scientific evidence will ensure that every child has the foundational skills necessary to successfully engage with text and experience the joy of reading. Reading comprehension, the ultimate goal of reading, relies on multiple skills, knowledge, and cognitive processes: including spoken language comprehension, accurate and automatic decoding, developed vocabulary, and background knowledge.

When students master foundational skills and experience reading success, they will continue to grow as readers, setting them up for lifelong success.

03	Job-Embedded Coaching	Intensive and personalized job-embedded coaching for up to 140 K-3 educators and leaders until Feb 2026
04	Literacy Learning Network	Network of leaders and educators engaged in a statewide community of practice
05	Guidance Documents and Resources	Guidance documents and resources for SU/SD focused on Act 139 implementation and evidence-based practices.
06	Family and Caregiver Engagement	Resources to support educators when engaging with families and caregivers
