Purpose of Act 28: • To improve literacy outcomes for all students • Addressing learning loss through evidence-based interventions Core Features: • Establish Literacy Council • Appropriated ESSER funds to support a position and PD Literacy Policy and Practice Drivers: • Act 28 • Act 173 • Local Comprehensive Assessment System • Coordinated Curriculum • Education Support Teams • Needs-based PD • VT Early Learning standards • EQS Updates on Act 28 (slides are posted on Council website): • Hired an Act 28 project manager • Established a cross-divisional team to coordinate literacy efforts across the AOE

Intent to roll out this summer. Focus of Playbook will be on implementation of the Blueprint.</i></li> <li>What do the Regional Labs do? There are Regional labs set up through US DOE to provide support to states.</li> <li>Is there a plan to assess the state of and impact of educator vacancies? There are efforts to address towrforce shortage undervay.</li> <li>Will the Playbook reference the revised Blueprint or the current Blueprint? Recommendations about revisions will be taken into consideration when developing the Playbook.&lt;</li></ul>
