# **Superintendent Waiver Request: M. Brott**

## **Revision of Policy F1: Foreign Credentials**

If the VSBPE decides to move forward with revisions, then the VSBPE will request that the Agency provide a proposed draft of any revised Policy consideration for vote and adoption at the 9 February 2023 meeting. ## **NVU/VtSU Five Course Sequence Proposal**

Clark moved that the Vermont Standards Board for Professional Educators allow candidates who complete the proposed NVU/VtSU special education course sequence to apply for initial licensure with a special education endorsement. This waiver would be in place through February 2026, at which time the board would review the program and determine future approval.
