### **Call to Order:**

E. Remmers called the meeting to order at 9:04am.

### **Approval of Agenda:**

J. Fribush moved to approve the agenda with a change to add a second waiver request. Seconded by C. Cole.

Agency of Education General Counsel, Emily Simmons gave a <u>presentation</u> explaining the Open Meeting Law and conflicts of interest.

# **Superintendent Waiver Request:**

J. Fribush moved that the VSBPE grant the waiver request for L. Wignall to have an additional 30 days of substituting for M. Wickens in Essex Westford School District provided that L. Wignall cannot make decisions regarding legal, curricular and assessment, and cannot develop IEPs. These activities must be done by a licensed special educator. Additionally, L. Wignall will receive weekly supervision including review of student progress, feedback/intervention on instruction, and lesson plan implementation.

Seconded by R. Reardon.

# **Superintendent Waiver Request:**

E. Remmers recused himself.

A. McMullen moved that the waiver request for Ms. Naylor is approved for Cambridge Pre-K to serve as a substitute teacher until the end of the school year. Seconded by S. Quinn.

T. Young amended the motion to include that the person supervising Ms. Naylor is identified. Seconded by C. Cole.

# **Early Literacy Bill Update:**

Bill H. 668 has been re-written to include language regarding a potential grant for SU/SD's to provide different types of Professional Learning. All concerns from the old bill have disappeared.

# **Modern and Classical Language Video Presentation:**

T. Reilly shared a video from Yara Hanna, the only educator in Vermont currently holding an endorsement in Modern and Classical Languages with an Arabic sub endorsement. Reilly to express their thanks to the educator who shared the video.

# **Secretary Daniel M. French:**

Secretary French spoke to the Board regarding Vermont's demographics and teacher pipeline.

Secretary French also updated the Board on State measures being taken to mitigate the spread of COVID-19.

# **VSBPE Action Regarding COVID-19**

R. Reardon moves that as PK-12 schools potentially move to online instruction due to closures on account of the coronavirus, teachers who do not have an Online Teaching Specialist endorsement shall be granted a waiver and be allowed to design and deliver on-line instruction until the end of the 2019-2020 academic year.

Seconded by C. Cole.

Motion approved.

C. Latulippe moves that the VSBPE approve the Agency's recommendation to hold a student harmless when student teaching placements are cut short due to a school or an Education Preparation Program closing due to coronavirus when the student has completed at least half of the required student teaching placement, receives a written recommendation of their efficacy from the cooperating teacher and the Education Preparation Program student teaching coordinator. This does not serve as a precedent for other reasons a student teaching placement might not reach the required thirteen weeks. Also, that the VSBPE approve the Agency's recommendation to grant a Provisional License to students when the student has completed at least half of the required student teaching placement to a school or an EPP closing due to



coronavirus and the student did not receive a written recommendation of their efficacy from the cooperating teacher and the EPP student teaching coordinator. This does not serve as a precedent for other reasons a student teaching placement might not reach the required thirteen weeks.

Seconded by C. Cole.

Program Approval Committee, R. Reardon reporting:

R. Reardon moves that the VSBPE accept the change to UVM's CAEP approval process, with the conditions that UVM will still need to request to use their CAEP approval towards their ROPA approval in 2023, per Policy N17 Policy on National Accreditation, and that if the VSBPE approves the request in 2023, that the AOE ROPA Coordinator participates in the CAEP review. Seconded by C. Latulippe.

Motion approved.

R. Reardon moves that the VSBPE accept Northern Vermont University-Lyndon's Teach-Out Plan for their Secondary Programs.

Seconded by J. Fribush.

Motion approved.

R. Reardon moves to table the Revised ROPA Standards until the Board's next meeting. Seconded by C. Latulippe.

Motion approved.

R. Reardon moves that the VSBPE approve the new review team members for NVU-Johnson's ROPA Review to be conducted on April 23-24, 2020.

Seconded by J. Fribush.

Motion approved.



R. Reardon moves that the VSBPE grant conditional approval of Champlain College's new Middle Grades and Secondary Math programs for two years with a Two-Year Report due in March of 2022.

Seconded by C. Latulippe.

Motion approved.

### Licensing Committee, C. Cole reporting:

C. Cole gave a recap of the discussion with UVM working group to partner with the University of Vermont to consider potential strategies to attract under-represented population to teaching by considering alternatives to established assessments.
