Educator Waiver Request: B. Bloomfield

B. Clark moved to approve the waiver for B. Bloomfield and allow him to apply for an administrative endorsement without the required three years of licensed teaching experience. Seconded by C. Kurucz.

Superintendent Waiver Request: S. Carpenter

B. Clark moved to accept the waiver request for S. Carpenter to allow Slate Valley UUSD to submit a one-year temporary license application with a Special Educator endorsement. The license shall be restricted to the Slate Valley UUSD.

Superintendent Waiver Request: S. Santaw-Wright

W. Lucci moved to allow North Country SU to apply for a two-year provisional license for S. Santaw-Wright with a Special Educator endorsement. The license shall be limited to the North Country SU.

Superintendent Waiver Request: H. Cummings-Washburn

A. Minor moved to grant an Emergency license limited to BUUSD to expire on 1/31/2023, contingent upon a submission of a mentoring plan including proposed meeting dates and curriculum support along with a plan for weekly supervision by a building-based supervisor and submission of their college prepatory observation dates.

Committee Reports and Motions

Licensing Committee

In-Car Driver and Traffic Safety Education endorsement without a BA/BS

J. Clement moved that the VSBPE not require a bachelor's degree for the in-vehicle only portion of the Driver and Traffic Safety Education endorsement and have five years experience as a licensed operator and be at least 21 years of age on date of application. Seconded by B. Clark.

Renewal Update

Approximately 90% of the expected renewal applications have been submitted. Applications have been submitted slowly over the summer. D. Giles has been communicating with the Local and Regional Standards Board regarding incomplete applications that have been approved by Boards this past Spring.

Special Educator Provisional Update

There are currently 45 Special Educator Provisional waiver applications in the work queue. This is an increase of 15 over last month. There are currently over 300 temporary applications in the work queue. Temporary applications include emergency, provisional and apprenticeship applications.

Program Approval Committee

SPARK ROPA Review Team

B. Clark moved that the VSBPE approve the team for the ROPA review of Spark's teacher preparation program which is scheduled for Dec. 1-2. Seconded by K. Revelle.

Middlebury College Approval Status

B. Clark moved that the VSBPE extend Middlebury's full program approval status pending review of their annual report.

Motion approved.

There has been a challenge with scheduling panel interviews for Peer Review candidates in specific endorsement areas. Candidates who have a temporary license and a completed portfolio are at risk of their license expiring.

The Board directed the Office to extend Provisional license expiration dates of affected educators to 12/31/22 to allow time for interviews to be completed as needed. The Office will notify the Board of the number of candidates in the upcoming Staff Report.

The Board broke for a 15-minute recess.

Grow Your Own Proposal

P. Halladay presented a <u>draft Grow Your Own proposal</u> to address some of the teacher shortage areas and received feedback from the Board.
