Superintendent Waiver Request - J. Carpenter

J. Fribush moved the VSBPE waive the requirement that J. Carpenter demonstrate coursework equivalent to Driver Ed I and II in order to qualify for a provisional license in Driver and Traffic Safety Education, with the understanding that none of this waiver waives any requirements for the in car portion of the Driver Ed endorsement and that the applicant receives mentoring as described in the waiver request.

Superintendent Waiver Request – M. Weaver

C. Cole moves that the VSBPE waive Rule 5355.1 and extends the provisional license for M. Weaver by one year.

Superintendent Waiver Request - J. Grutta

J. Fribush moved the VSBPE waive the requirement for J. Grutta Director of Special Education license in 5355.1 that Special Education endorsements are not allowed to request a third year provisional. Upon application by the Supervisory Union, the AOE will evaluate the extenuating circumstances and make the final determination.

Educator Waiver Request - L. Leff

J. Fribush moved the VSBPE waive requirement 5323 that teachers who already have a license in VT are not allowed to use reciprocity to reinstate their license. Seconded by A. Minor.

Program Approval Committee, R. Reardon Reporting:

R. Reardon moved that the VSBPE accept the report of the ROPA review team and grant two-year conditional approval to Vermont Higher Education Collaborative's (HEC) Early Childhood Education, Early Childhood Special Education, and Special Education programs. Seconded by C. Latulippe.

Motion approved.

The PAC discussed a change in the ROPA Review Team for Lyndon. Student Teacher Placements discussion seems to be an isolated incident.
