L/RSBs: A September reminder was emailed to all L/RSBs which still needed to submit a required L/RSB component.

The GMS system was opened for L/RSB Grants on Friday, September 27, 2024. Earlier in the week all eligible Boards were emailed their respective grant allocation with directions. The Business Managers were cc'd on the email. To date a few SU/SDs have submitted their Grant application via GMS, been reviewed, and forwarded to AOE Finance for the second review. Nest the Grants will be reviewed by our Division Director (Josh Souliere) with the final review and acceptance by the AOE CFO, Sean Cousino.

All LSB 2025 Renewal Lists have been emailed to LSB Chairs and Co-Chairs. The RSBs received the individual list for each SU/SD served by that RSB. Each list is only as valid as the employment section of an educator's profile on the day the list is created. Boards were notified of conflicting email addresses in their respective lists.

At the beginning of October, there were still ten (10) 2024 renewals waiting to be processed. Two had yet to submit their final payment and the remaining eight were waiting for a Criminal Record Check Report from VCIC.

Deb will be out on leave and a plan was developed by the Licensing Team to respond to L/RSBs in case of an emergency. The plan was shared with L/RSBs.
