Special Education Provisional Waivers:

Currently we have 90 applications that were initiated for the 2023-2024 school year.

That represents about 33 SU'S/SD'S/Private schools who have submitted applications. The breakdown of instructional levels is below:

59 applicants or 75% have completed their modules and praxis II exam

Deb Giles May 2024:

<u>L/RSB</u>: Renewals are continuing to be processed quickly *if* all information in the application is clear and accurate and the educator does not need a new CRC for the AOE.

Annual L/RSB Surveys are being created to email to all Boards in late May/early June. Regional trainings for Superintendents and HR personnel have been scheduled at three venues and sign-ups are now on-going for those trainings.

Grant Scope of Work Documents have been prepared and information regarding fiscal agents for RSBs and private LSBs is being collected.

Three Summer Conferences for L/RSBs have been arranged with venues and awaiting finance approval before dates and sign-ups are released to the field.

Deb also continues to address questions and concerns from L/RSBs and educators regarding relicensure.
