Education Quality Team Staff Report for 28 of March 2024

Updates:

Renewals are in full swing. We anticipate receiving around 3,709 this year, which include level I and level II licenses.

Wendy Scott and Tammy Bates from the AOE Universal PreK Program are planning on expiring the AOE ECE/ECSE provisional license waiver as of 6-30-25. The waiver is currently expected to expire on 6/30/2026 but due to lack of mentor funding, fewer applicants applying who have very little experience in early education, they have determined not to continue the waiver.

Rob Schulze, Associate Professor Special Education from Vermont State University wanted to pass on a issue for the board to monitor. They are placing special education teacher prep students in placements for the fall, and are having a very hard time finding schools that have a licensed special educator in them. There are so many schools that are saying they would love to have a student teacher, but every single one of our special educators is on a provisional. This is of course making it harder to create new special educators who are licensed, since there is a lack of places to place them for training, which potentially makes the shortages worse, making it a self-perpetuating problem. If it gets to the point where we literally can't find a placement, we may need to ask for some sort of relief.

Currently we have 91 applications that were initiated for the 2023-2024 school year.

That represents about 32 SU'S/SD'S/Private schools who have submitted applications. The breakdown of instructional levels is below:

- 91 Special Education Waiver Provisional applications submitted.
- 52 of the applications represent Grades K through Age 21 Special Education
- 18 of the applications represent Grades K through 8 Special Education
- 9 of the applications represent Grades 7 through Age 21 Special Education
- 2 of the applications represent Birth through Age 6 Early Childhood Education.
- 10 applications closed.

L/RSB:
