### Career foundations pilot updates - feedback from Vermont Afterschool

- 4 programs ran over the summer 2024 Williamstown, Northfield, Missisquoi Valley U/St. Albans Tech Center, King Street.
  - All sites had very different methods.
  - Williamstown had all summer program middle schoolers participate mixed in with activities; site visit – pretty successful; brought in 4 guest speakers – farmer, Katherine Patterson, photographer.
  - Northfield two weeks every day had about 5 to 7 students regularly; for future, requesting adaptations for special education students; high school student led; challenging to get engaged speakers.
  - King Street would like to use essence of content to create a bridge program into their ACE high school (academic and career exploration program) -<u>https://www.kingstreetcenter.org/ace</u>; did resume building and had customer service guests.
- Missisquoi Valley career fair at the end of the week On Logic, Swanton public works, fire station, community representatives. The week before career fair, bused to



tech center to experience career interest and specialists of each group then incorporated it into their programming. Did lots of trips to businesses.
