# Secondary Dual Enrollment and Early College Participation Agreement Form FY23 Preview

#### **Dual Enrollment & Early College Overview:**

Under the Flexible Pathways Initiative, the State has encouraged and supported school districts in offering high-quality educational experiences. Two such experiences, Dual Enrollment and Early College, allow school districts to offer post-secondary experiences to students to meet graduation requirements. The Vermont Dual Enrollment Program, 16 V.S.A. § 944, provides eligible Vermont high school students access to two college courses, tuition free, through a voucher system that tracks requests, collects information for reporting, and allows for accurate reimbursement to participating partners. Vouchers are awarded on a semester-by-semester basis, pending student eligibility. Developmental/remedial courses do not qualify for Vermont Dual Enrollment vouchers. The Early College Program, 16 V.S.A. § 946, allows seniors who enroll to take a full year of college-level courses tuition free. Student readiness for and participation in college coursework must be determined by their principal and/or their designee and documented in the student's Personalized Learning Plan.

#### **Definitions:**

"**Dual Enrollment**" means enrollment by a secondary student in a course offered by on accredited postsecondary institution and for which, upon successful completion of the course, the student will receive: (A) secondary credit toward graduation from the secondary school in which the student is enrolled; and (BJ postsecondary credit from the institution that offered the course if the course is a credit-bearing course at that institution.

"*Early College*" means full-time enrollment, by a 12th grade Vermont student for one academic year in a program offered by a postsecondary institution in which the credits earned apply to sJwnWj2f school graduation requirements.
