CONTRACT TERMS AND ADDITIONAL INFORMATION

- 1. Parties. This is a contract for services between the State of Vermont, Department of Buildings and General Services (hereafter called "State" or "Owner"), and ENA SERVICES, LLC, with a principal place of business in Nashville TN, (hereafter called Contractor). Contractor's form of business organization is an LLC. It is the contractor's responsibility to contact the Vermont Department of Taxes to determine if, by law, the contractor is required to have a Vermont Department of Taxes Business Account Number.
- 2. Subject Matter. The subject matter of this contract is services generally on the subject of broadband access under the federal e-rate program. Services to be provided by the contractor are described in Attachment A.
- 3. Maximum Amount. In consideration of the services to be performed by Contractor, the Owner agrees to pay Contractor, in accordance with the payment provisions specified in Attachment B, a sum not to exceed \$0.00.
- 4. Contract Term. The period of contractor's performance shall begin on July 1, 2015, and end on June 30, 2017, with two renewal options, each option will be for a period of 12 months.
- 5. Prior Approvals. If approval by the Attorney General's Office or the Secretary of Administration is required, (under current law, bulletins, and interpretations), neither this contract nor any amendment to it is binding until it has been approved by either or both such persons.
- Approval by the Attorney General's Office is required.
- Approval by the Secretary of Administration is not required.
- Approval by the CIO/Commissioner DII is not required.
- 6. Amendment. This agreement represents the entire agreement between the parties; No changes, modifications, or amendments in the terms and conditions of this contract shall be effective unless reduced to writing, numbered and signed by the duly authorized representative of the Owner and Contractor.
- 7. Cancellation. The State specifically reserves the right to cancel the contract, or any portion thereof, if, in the opinion of its commissioner of Buildings and General Services, the services or materials supplied by the contractor are not satisfactory or are not consistent with the terms of the contract.

This contract may be canceled by either party by giving written notice at least 45 days in advance.
