I am writing to request a waiver, pursuant to section 8401 of the Elementary and Secondary Education Act of 1965 (ESEA), of the following requirements as a result of ongoing challenges related to the novel Coronavirus Disease 2019 (COVID-19):

I am requesting this/these waiver(s) because it is not possible to obligate funds on a timely and responsible basis.

Consistent with the requirements of ESEA section 8401(b)(1)(C) and (F), describe how the waiving of such requirements will advance student academic achievement and how schools will continue to provide assistance to the same populations served by programs for which waivers are requested.

The state of Vermont is requesting the above described waivers due to the difficulty to obligate funds in a timely and effective manner since spring 2020. The COVID-19 pandemic exacerbated significant workforce challenges throughout Vermont, and the disruption of typical programing and services has resulted in many LEAs struggling to spend funds while also creating an even greater need for those resources and services. In addition, LEAs have used recovery funds to address many of their needs over the past two years, and they are now planning for how to sustain ESSER-funded academic and mental health recovery activities in preparation for the expiration of these emergency funds. Providing expanded access to LEAs' unspent or unobligated FY2020 ESEA funds will assist in this transition process.

A number of local education agencies (LEAs) have reiterated to the federal programs team at the Vermont Agency of Education how the continued disruption of the pandemic has resulted in significant spending challenges. LEAs have shared concerns over their ability to utilize available funding before it expires. This waiver will allow many of our LEAs to fully fund essential programs and services that will meet the new and increased needs of our student population as our state continues to transition out of the pandemic. Extending the tydings period for Title IA, IIA, IIIA and IV A funds will assist LEAs to fully realize their planned activities related to improving the capacity
