

Special Education Monitoring Cycle SY 2020 -2021



Although Vermont’s previous monitoring system (compliance and graduation/drop out review conducted on a six year cycle) met the letter of the law, the Agency was not meeting the intention of the Office of Special Education Program’s (OSEP) guidance to really make a difference in improving outcomes for students with disabilities in Vermont. Beginning with school year 2019-2020, the former six-year monitoring cycle was replaced with a more frequent monitoring cycle where LEAs with a “meets requirements” on state issued LEA special education determinations can expect a minimum of a file review on a three-year rotating basis. Minimally, LEAs will be monitored for activities identified in the table below, as well as additional activities based on any identified areas of non-compliance found during the current year’s review.

Criteria for this year’s cycle includes selective monitoring for LEAs identified from 2019-2020 monitoring activities related to non-compliance on submissions for post-secondary transition plans. LEAs will receive targeted technical assistance in this area prior to re-submission during this year’s monitoring cycle.
