Error Prone Applications

Annual	Error-prone applications are those applications where income falls between the income eligibility guidelines limits and \$1200 of the income eligibility limits for Annual income.
Monthly	Error-prone applications are those applications where income falls between the income eligibility guidelines limits and \$100 of the income eligibility limits for Monthly income.
2X Monthly	Error-prone applications are those applications where income falls between the income eligibility guidelines limits and \$50 of the income eligibility limits for Twice Per Month income.
Bi-Weekly	Error-prone applications are those applications where income falls between the income eligibility guidelines limits and \$46.15 of the income eligibility limits for Bi-Weekly income.
Weekly	Error-prone applications are those applications where income falls between the income eligibility guidelines limits and \$23.07 of the income eligibility limits for Weekly income.
