- The SFA did not provide the correct timeline of 10 operating days when reducing benefits and sending the adverse action letter home to households.

- Point of service meal count practices were found to be inconsistent.
- Pre-K meals at Derby are not counted at the point of service.

- Newport Town and Derby Elementary school are not incorporating whole grain rich products into their daily menu options.
- Newport Town Elementary School is not using the correct production records to record breakfast and lunch meal production.
- Newport Town and Derby Elementary School are not ensuring that there are child nutrition labels or product formulation statements for required products
- Newport Town and Derby Elementary School are serving meals to Pre-K students in their classroom and utilizing the NSLP meal pattern instead of the CACFP meal pattern.
