## Introduction

This is the annual report of the number of students approved for free and reduced-price meals in each school in each School Food Authority (SFA). A School Food Authority (SFA) is the entity responsible for operating the National School Lunch Program (NSLP) and the School Breakfast Program (SBP). In Vermont, the SFA is at the Supervisory Union level for public schools. In some cases, there is more than one school district within a School Food Authority. State approved and state recognized independent schools can take part in the school meals programs as their own SFA or as sites under a public SFA.

Starting in School Year 22-23, the state has required all public schools to offer meals at no charge to all students. State funds cover these costs. State-approved independent schools that offer meals at no charge to all students receive state funds to cover the cost of providing meals to students attending on public tuition. This means that meals are being provided at no charge to all students at all public schools and at some independent schools. A few independent schools charge students for meals. At these schools, state funds pay for the student's share of reduced-price breakfast and lunch.

## Changes from Prior Years

Vermont began participating in the [USDA Medicaid Direct Certification Demonstration Project](#) in August 2024. This allows the state to share information with schools about students who qualify for free and reduced-price meals because they participate in Medicaid and live in households with incomes under 185% or 130% of the federal poverty level. This project has been very successful at identifying additional students who qualify for free and reduced-price meals. As a result, many Provision 2 and Pricing schools have seen an increase in their free and reduced percentages in School Year 23-24. This is especially true when compared to School Year 22-23. In School Year 22-23, there was little incentive for households to return free and reduced meal applications as meals had been served at no charge for several years. As a result of these changes, free and reduced percentages may not be an equivalent metric of student poverty when compared year to year for the past several years.

## Date of Data

The report shows the total number of students approved for free and reduced-price meals and the total number of students enrolled. This information is as of the last operating day in October of the current school year, as reported by the SFA. Please note that other measures of student poverty in Vermont may report similar information, but as of the first day

of October. These numbers may be different. A recent USDA rule change has allowed more schools to participate in the Community Eligibility Provision (CEP). Vermont received flexibility from USDA to allow schools to start new CEP cycles using data from September 2023. That flexibility didn't go into effect until December 2023. Some schools operated Provision 2 until November 30, 2023 and then switched to CEP. Other schools that were already operating CEP re-started their CEP cycles in December 2023 using the higher data from September 2023. **This report shows the provisions and percentages that were in effect as of October 2023. The AOE will publish a supplemental report that shows schools participating in CEP and Provision 2 as of December 2023.**

## Where This Information Comes From

Students can be approved for free or reduced-price meals in several ways. One way is that the household submits an application. Another way is that the student participates in another means-tested program. To qualify as income-eligible for free meals based on an application, a household's income must be at or below 130% of the Federal Poverty Level. To qualify as income-eligible for reduced price meals, a household's income must fall between 130% and 185% of Federal Poverty Level. The Federal Poverty Level is updated annually. Households may be Directly Certified for free meals when someone in the household receives 3SquaresVT (SNAP) or Reach Up (TANF), or students are determined categorically eligible through Foster, Homeless, Migrant, Runaway, or Head Start. Eligibility determinations are made at the SFA- or school-level by the determining official. The determining official might be the Food Service Director, Administrative Assistant, or another school administrator.

The information in this report is based on the data that SFAs submit in the annual Site Enrollment Report. The percentages are calculated for all schools in the system participating in the National School Lunch Program.

## What (++) Means

The data reported meets Vermont Agency of Education [data governance requirements](#) which eliminate any sensitive and/or potentially personally identifiable information from fewer than 11 students. As a result, some information from some schools is not available, and is replaced with two plus signs (++)

## How the Report is Organized:

The report is organized alphabetically by Supervisory Union/SFA. The schools participating within the Supervisory Union are listed alphabetically by school name. Independent schools who participate in the National School Lunch Program are included alphabetically, except when they participate as sites under another SFA. In that case, they are listed under that SFA.

## CEP Schools

Schools participating in the Community Eligibility Provision (CEP) are marked with a “Y” in the CEP Column of the Report. CEP allows schools to serve meals at no charge to students; schools receive the free and paid reimbursement for meals served. Schools eligible to participate in CEP must have at least 25% of their enrolled students Directly Certified for free meals or participate in a group of schools with a combined total of at least 25% of enrolled students Directly Certified for free meals. This Identified Student Percentage (ISP) is multiplied by the USDA multiplier of 1.6. The result is the percentage of meals to be claimed at the free rate. Per USDA guidance, for CEP schools, individual school data must be used to determine the free and reduced rate, even if the school is participating in CEP as a group claiming with a shared free claiming percentage. This percentage is applied to the total enrollment as of the last operating day of October. Schools operating CEP as of October 31, 2023 are indicated below. Additional schools began operating CEP in December 2023. Those schools are not indicated as CEP in this report.

## Provision 2 Schools

Schools participating in Provision 2 for Lunch are marked with a “Y” in the Provision 2 column of the Report. In Provision 2, schools collect applications in a “base year” and use that information for the following 4 years. The base year percentages may be extended for an additional 4 years beyond that if the SFA can provide information showing that the demographics have not changed since the base year. For non-base year Provision 2 schools, the free and reduced percentages from applications collected in the base year have been applied to the school’s current year enrollment (as of the last operating day of October). For more information on Provision 2, please see the [USDA Factsheet](#). Please note that some schools switched from Provision 2 to CEP in December 2023. Those schools are listed as participating in Provision 2 in this report.

## Statewide Average

The statewide total enrollment of students (from available data) in school lunch programs is 82,617. The total number of students approved for free and reduced price meals is 39,488. The statewide percent free and reduced students as of October 31, 2023 is 47.8%.
