RE: Proposed Updates to Rule 2000, Education Quality Standards (EQS)

The purpose of this memorandum is to provide a high-level overview of the proposed updates to State Board of Education Rule Series 2000 (Education Quality Standards, EQS) for your consideration and approval at the special meeting of the State Board on Education on Thursday, April 13, 2023.

Background

At the April 2022 State Board of Education (SBE) meeting, the Ethnic and Social Equity Standards Advisory Working Group (Act 1 Working Group) submitted proposed revisions to Rule Series 2000 - Educational Quality Standards Manual. The Act 1 Working Group was charged with reviewing standards for student performance adopted by the SBE under 16 VSA Section 164(9) and other state statures, SBE rules, and school district and supervisory union policies.

Act 1 charged with Working Group with recommending additional standards designed to:

- 1. Increase cultural competency of students in grades PK-12;
- 2. Increase attention to the history, contribution, and perspectives of ethnic and social groups;
- 3. Promote critical thinking regarding the history, contributions, and perspectives of ethnic and social groups;
- 4. Commit schools to eradicating racial bias in their curricula;
- 5. Provide, across their curricula, content and methods that enable students to safely explore questions of identity, race equality, and racism; and
- 6. Ensure that the basic curriculum and extracurricular programs are welcoming to all students and account for parental concerns about religion or culture (Act 1 of 2019, Section 1(g) Duties of the Working Group).

The Working Group was comprised of 20 members, representing diverse perspectives and communities and the Group included a representative from Vermont's Agency of Education (AOE). The Working Group's recommendations were informed by research and policy, lived experiences of Vermont students and families, and more than a year of deliberations.

The recommended changes to the EQS were unanimously approved by the Working Group, except for the representative from the Vermont Independent Schools Association (VISA). In testimony to the SBE's EQS Committee, VISA shared that it supports the Working Group's recommendations for expanded standards, and only objected to the Working Group's recommendation that the EQS be universally, and equally, applied to Vermont's independent schools.

Work Undertaken by the SBE EQS Committee

The SBE's EQS Committee (Comprised of co-chairs Gleason and Kolbe, and members Brown, Lovett, and Lucci) was charged with updating the EQS to comply with Vermont Act 1 of 2019 and other recommendations by the AOE and others for the purpose of policy coherence and alignment.

The Committee's considerations for potential revisions to the EQS were framed and constrained by existing statute, particularly Act 1 of 2019, 16 VSA 165, and 16 VSA 164(9). The Committee carefully reviewed existing statutory requirements, the Act 1 Working Group's recommendations, recommendations proposed by the AOE for technical questions, and recommendations from the field to ensure that revisions to the EQS would be implementable.

The EQS Committee work began with review of those sections that had the most substantial recommended changes. *Section 2114 Definitions* reflected recommendation for revisions to existing terms and the addition of definitions for several new terms. Recognizing that a common understanding of the terms within the document is foundational to the ability to carry out the directives of the EQS, the Committee took testimony throughout the summer from many stakeholders, including those representing the Jewish Communities of Vermont. This stakeholder testimony informed the Committee revisions to the Section 2114 Definitions.

The other sections with more substantial recommended revisions included *Section* 2120.1 *Instructional Strategies* and *Section* 2120.5 *Curriculum Content*. The next several meetings invited testimony from practitioners in the field. The Committee asked the presenters to reflect on the recommended revisions and consider the following questions:

- 1. Are the rules clear as written?
- 2. Do they strike an appropriate balance between offering enough detail to be understood, and enough flexibility to ensure application in a local context?
- 3. Are these rules able to be operationalized in our schools?

The Committee invited practitioners from the field to testify and provide input on these questions. Universally, the Committee heard that the proposed changes are clear, strike an appropriate balance, and can be operationalized in our schools. Without exception, the representative from the field that came before us welcomed these revisions to align with the values of their school districts and the needs of their students.

The AOE offered technical suggestions and provided responses to clarifying questions throughout the process. The AOE also offered recommendations for alignment with the proposed Draft District Quality Standards/Quality Assurance Review (DQS/QAR). The

Act 1 Working Group was consulted and provided feedback on EQS Committee questions and considerations for edits throughout the process.

The EQS Committee consulted with an independent outside counsel and the document presented to the SBE for consideration underwent an initial legal review for consistency with existing stature. A second review will be requested after the SBE's deliberations and before the Rule is submitted to ICAR.

The Committee held a public listening session on November 30, 2022, and heard from more than 30 participants. All were in support of the recommended changes to the EQS.

Additionally, the Committee heard from and considered recommendations from the Vermont School Boards Association, Vermont Superintendents Association, Vermont Principals Association, Vermont-National Education Association, Vermont Curriculum Leaders Association, Vermont Special Education Advisory Panel, Vermont Student Anti Racism Network, and the Vermont Independent Schools Association (VISA). All organizations expressed support for the values of equitable, anti-racist, culturally responsive, anti-discriminatory and inclusive educational opportunities for Vermont students, as articulated in the proposed revisions to the EQS. VISA supported the substance of the rule, but did not support extending the EQS to universally, and equally, applying to independent schools.

On April 10, 2023, the EQS Committee ratified the draft rule presented to the SBE for consideration, by a unanimous vote. With that vote comes the Committee's recommendation that the full SBE approve the proposed revisions to the EQS rule.

Issue for SBE Considerations

A key issue considered by the Committee was *to whom* the rule should apply – specifically, should the EQS apply universally, and equally, to independent schools that receive public tuition dollars. (See attached/related memo that provides an overview of the issue.)

In its work, the EQS Committee received testimony from VISA, two accrediting agencies (NEASC and AISNE), several independent schools, (including Thetford Academy which is an independent school that chooses to comply with EQS, Superintendents, and St. Johnsbury Academy). All supported Act 1's principles and goals and agreed that social and ethnic standards, consistent with what was proposed by the Working Group, should be applied to independent schools who receive public tuition. However, the point of disagreement was whether the EQS was the appropriate regulatory mechanism for achieving this goal, or if another approach (or approaches) were more appropriate in the context of existing statute.

The Committee agreed that the issue of whether to apply the EQS to independent schools or to develop an alternative regulatory framework that would extend Act 1's

principles and goals to approved independent schools is an issue that should be resolved by the full SBE.

Recognition & Gratitude

The EQS Committee recognizes the thoughtful work by the Act 1 Working Group and the substantial contributions by a diverse group of Vermonters who care deeply about ensuring that all Vermont students are afforded an equitable education. It is with gratitude for these contributions and foundational work of all those who have been engaged with this effort, we submit the Draft EQS Rules revision for the consideration by the SBE.

Overview of EQS Committee Work

- Charge:
 - o Pursuant to <u>Title 16 of the Vermont Statutes</u>, <u>Chapter 3</u>, the State Board of Education is responsible for the establishment, advancement, and evaluation of public education policy. The powers and duties of the Board include making <u>regulations</u> governing: attendance and records of attendance of all pupils, standards for student performance, adult basic education programs, approval of independent schools, disbursement of funds, and equal access for all Vermont students to a quality education. The governing regulations are outlined in the <u>State Board of Education</u> Rules.
 - The State Board of Education Education Quality Standards (EQS) Committee is charged with updating Vermont's Education Quality Standards (Rule Series 2000), for compliance with Vermont Act 1, and other recommendations from AOE or others for the purpose of policy coherence and alignment. The EQS is the body of state education rules that set standards for educational quality and equal educational opportunity in Vermont.
 - This committee will review these rules in the context of the relevant legal framework, recommendations from Act 1, and others, and the committee will identify changes in language to existing rules, as well as changes to statute that are necessary to implement the revised rules. The Committee's work will include careful review of existing statutory requirements, recommendations of the Act 1 working group and the AOE, and substantive stakeholder input.
 - The Committee will submit proposed Draft EQS Rules updates to the full State Board of Education for review and approval (December-January).
 - Upon approval by the full State Board, the EQS will enter the ICAR/LCAR formal adoption process, which will include additional formal public comment period and will be concluded within eight months, at which time the rules will be adopted.

June 23, 2022 - April 10, 2023 - EQS Committee met 28 times to hear testimony, discuss and deliberate possible revision to EQS Rules. Minutes and those invited to testify can be found noted below.
