June 2020	<b>17 June SBE meeting: SBE to close public comment period.</b> SBE to reflect or public testimony, review <i>SBE PROPOSED RULES</i> , and determines revisions to be incorporated in <i>SBE FINAL RULES</i> to be adopted by SBE in July.	
July 2020	(1 July 2020 = last date for SBE to start Rulemaking process, per Act 173, Sec 16.)

## SBE FINAL RULES AT LCAR >>> SBE RULES go into effect

August 2020	early August: LCAR to conduct hearing on SBE FINAL RULES. mid-August SBE meeting: AoE to brief SBE to on status of LCAR review.
September 2020	mid-September SBE meeting (allowing 45 days for LCAR review):  *SBE* to file SBE FINAL RULES with SoS.
October 2020	early October (fifteen days after filing with SoS):  SBE FINAL RULES to become effective. *SBE* to notify School districts
November 2020	(late November: eight-month maximum allowable APA Rule-making period expires)
