## Call to Order/Amendments to Agenda/Introductions

Chair Davis called the meeting to order at 1 PM.

## **Opportunity for Public to be Heard.**

Karen Price of the Vermont Family Network. VFN works with families of children with disabilities and special health needs and operates a helpline. Ms. Price provided examples of calls that have been received, including many related to bullying and harassment. Ms. Price noted that children with disabilities often lack the social ability to be covert regarding bullying and harassment and end up in disciplinary proceedings related to this at higher rates than peers without disabilities. Children with disabilities also get bullied by kids who do not have disabilities. VFN sees a lot of suspension and removal of students with disabilities. Ms. Price noted the lack of independent reviewers for schools. Some families have had to wait at least a year for an independent review. Children who have invisible disabilities and who do not have IEPs or 504s do not have any supports. There is an online form that AOE has built on their webpage. The information provided by the AOE has been inconsistent about the purpose of the form. VFN had heard that there were supposed to be updates to the HHB policy that are overdue and have been on hold, and they are concerned about this.

## Approval of November 6, 2023 Draft Meeting Minutes

The working group continued to discuss potential recommendations using a Miro board. Recommendations were grouped according to the charge of the Working Group.

The group decided to attempt to finalize recommendations at the next meeting on December 4<sup>th</sup> and work on finalizing the report at the meetings on December 18<sup>th</sup> and January 8<sup>th</sup>. Several subcommittees will work to advance specific recommendations before the next meeting, within Open Meeting Law requirements.

Jay Nichols agreed to present his survey of school administrators at the next meeting.
