Call to Order/ Roll Call/Amendments to Agenda

The meeting was called to order at 6:03pm.

Co-chair Gleason reviewed the EQS Update Committee process to date (*see attachment*), indicated that the committee had held 11 meetings to date to consider the Act 1 proposed changes to the Education Quality Standards (EQS). The Committee heard from the field and public focusing attention on the definitions and instructional practices sections, with the greatest proposed changes. The Public Listening

session was to hear from others regarding the proposed updates to the rules to inform the work of the Committee in advance of bringing a draft to the full board for approval to move into the administrative rules process.

Gleason reminded attendees of the need to keep comments respectful, directed to the Committee and to keep comments to two minutes to allow for as many participants as possible.

Public to be Heard

The Committee heard comment from 31 participants in the call. All those testifying offered support for the updating of the EQS in alignment with the mandates of Act 1. The feedback generally offered support for the Act 1 proposed changes to the EQS. Parents, educators and community members spoke of the need to ensure that "...all students in Vermont schools are afforded opportunities that are equity, anti-racist, culturally responsive, anti-discriminatory, and inclusive..." Many felt these proposed standards went a long way to ensuring that Vermont students experience a welcoming, inclusive, safe environment that reflects their lived experiences, allowing students to see themselves and the world through "windows and mirrors". The Special Education Advisory Panel offered specific recommended changes (see attached testimony) and the Jewish community advocated for inclusion of reference to Holocaust and anti-semitism education, and to include those who have historically been subject to persecution and genocide. (These considerations had already been reflected in the most recent Committee draft of the proposed EQS.) Those testifying expressed gratitude for the efforts and inclusive process of the Act 1 working group and the continuing work of the EQS Update Committee.

The EQS Committee expressed gratitude for the time that community members took to share their feedback with the committee.

Adjourn

At 8:02pm, Tammy Kolbe made a motion to adjourn and Patrick Brown seconded. The motion passed unanimously.
