Title I 1003 School Improvement Grant Monitoring

Purpose

The purpose of this document is to describe the monitoring process for Title I 1003 School Improvement Grant awardees and their proposed activities/investments. Monitoring takes place to assess the improvement of student outcomes based on the indicators in the statewide accountability system (1111(d)(2)(B)). The monitoring consists of a set of questions for the LEA and school(s) as well as a summative report including any findings and best practices.

Monitoring Process

LEAs awarded with 1003 School Improvement (SI) grant funds will be monitored twice per year, once in February and once in June.

To complete the monitoring process, the LEA and its identified schools will:

- Log into the GMS (Grants Management System), click on Title I SI Monitoring (Title I – SI – OM).
- 2. Open your SU/SD's monitoring section.
- 3. Complete all tabs in order.
- 4. Under the Mid-Year Monitoring tab, download and complete Excel document with monitoring questions.
- 5. Respond to these questions (with technical assistance from AOE, as needed). and upload responses to the GMS.
- 6. Meet with the School Improvement Grant Coordinator to discuss responses. The Grant Coordinator will organize virtual meetings.
- 7. Review the AOE draft report for confirmation of findings.

AOE will publish the final report to GMS.



Monitoring Inquiry Protocol

- 3. Describe to what degree your grant activities and related investments have contributed to student learning/outcomes and your CIP goals.
- 4. What are your next steps?
